05: Report on matters arising from the meeting not covered elsewhere on the agenda;

- South West Collaboration meeting on 19th January was held at Hyde Lea & Coppenhall Village hall, staring at 7.00pm. Notes on the content had been circulated prior to tonight's meeting and various points were discussed, next Collaboration meeting is on 27th April.
- Phone box; clerk advised that he had contacted Stafford Borough Planning about the parish adopting the phone box, however nothing has been heard from BT to date
- Defibrillator batteries/pads; the battery is alright for the moment but the pads have an expiry date of April 2017. Clerk to contact supplier.
- Road sweeping; has been done through the village to a high standard.
- Section 137 allowance; is an annual amount based on the number of residents which empowers the parish council to spend to the benefit of the community.
- Precept; has been confirmed as a 4.73% rise.
- Training courses; Councillor Wilkes reported that the Local Councillor training course she attended had been well
 presented and useful. However, the previous course on Development Control was marred by a poor trainer who did
 not engage with the audience nor answer questions.

10: Roads, Highways & Footpaths;

Hyde Lea Bank drainage; large volume of water cascading down bank.

Barn Bank Lane drainage; complaint from resident that gullies do not clear rainwater.

NB; a meeting has been organised with Highways on 10th March to discuss these 2 issues.

Speed Indication Device; Safer Road Partnership can no longer provide information due to IT issues.

Kissing gate on Green lane; supplier requires £75 delivery. Clerk to find out weight and dimension of kit so it can be collected.

Bradley Lane bridleway; is still closed due to flooding

Drumbles; the state of the footpath is now a Health & Safety issue. Councillor Edwards offered to contact Rights of way.

Green lane styles; are narrow although farmer confirmed that they complied with NFU guidelines.

11; Planning issue relating to Manor Nursing home.

The meeting plus Councillor Sutherland, discussed Application 17/24877/REM relating to building work planned at the nursing home. It was agreed that a site meeting be held with the architect and Chief Executive of the nursing home to discuss the problems and hopefully resolve them before the planning committee convened.
